I am directed to say that the post of Presiding Officer, Central Government Industrial Tribunal-cum-Labour Court (CGIT-cum-LC), Nagpur is to be filled up shortly in accordance with the provisions contained in sections 7 & 7A of the Industrial Disputes Act, 1947. According to these provisions the post can be held by a Judicial Officer who is, or has been, a Judge of a High Court or who has rendered not less than three years service as Additional District Judge or District Judge. A serving Judge can be appointed on transfer on deputation basis for a fixed term. A retired Judge can be appointed on re-employment basis. The terms and conditions of appointment of Judges to the post of Presiding Officer will be as per Annexure [The Presiding Officers of the Labour Court, Industrial Tribunal and National Tribunal (Salaries, Allowances and other Terms and Conditions of Service) Rules, 2015].

2. The scales of pay attached to the post of Presiding Officer of the CGIT-cum-LC, 'Nagpur are as follows:

The nomination of Judicial Officers may please be forwarded along with abstracts of ACRs of the last five years duly certified in the enclosed proforma along with the ACR dossiers and vigilance clearance at the earliest possible date.
