In Re Suo Moto V/S State of J&K and Ors and connected matters (PIL No. 8/2008 and PIL No. 628/201), the Hon'ble DB of the High Court of Jammu and Kashmir on 13-08-2018 was pleased to issue the following direction:

"Given the fact that the District Judges are required to regularly and properly conduct the inspection of the Jails to ensure the requirement of the Criminal Procedure Code as well as the judicial pronouncements by the Supreme Court and this Court relating to the prisoners, interest of justice merits that such reports are submitted online to the Registry of this Court by the Judicial Officers. We, therefore, direct the Central Project Coordinator (CPC) e-Courts attached to this Court to take steps for the development of appropriate software at the earliest so that proper scrutiny of the compliance can effectively be conducted."

Accordingly, the development team of the High Court has prepared a software through which the PDJs can now submit their monthly Jail Inspection Reports to the High Court online without forwarding their hard copies.
