Whereas, one Irfan Rashid Dar, aged 33 years S/o Abdul Rashid Dar R/o Hari Parigam Awantipora, Pulwama, alongwith other thirteen petitioners, having common interest in the subject matter of the writ petition, have filed the above titled writ petition through their counsel Mr. T.A.Lone, Advocate, impugning therein the Judgement dated 28.02.2023 passed by the Central Administrative Tribunal in T.A. No.5094 of 2020 bearing SWP No.392/2019 titled Nayeem Ahmad Wani and others V/S State of J&K and others.

Whereas, the petitioners, in the writ petition, have sought the following reliefs:-

- a) *A writ of certiorari for quashing the impugned judgement /order dated 28.02.2023 passed by the Central Administrative Tribunal in T.A No.5094 of 2020 bearing SWP No.392/2019 titled Nayeem Ahmad Wani and others V/S State of J&K and others, in terms of which T.A./Writ petition filed by the petitioners herein has been dismissed.*
- b) *A writ of certiorari for quashing the selection list dated 09.02.2019 issued by respondent no.2 for the posts of Constables SDRF advertised vide Advertisement Notification No. Pers-A-Aux-Police-03-11/40355-474 dated 24.08.2012, particularly the selection of the private respondents who are lower in merit and are equal in number with petitioners.*
- c) *A writ of Mandamus for commanding the official respondents to consider the case of the petitioners for selection against the aforementioned vacant/advertised posts of Constables SDRF J&K advertised vide Notification No. Pers-A-Aux-Police-03-11/40355-474 dated 24.08.2012.*
- d) *A writ of mandamus commanding the official respondents to produce the record pertaining to publishing of Notification bearing No.1495 of 2017 dated 27.4.2017 in any of the leading local dailies.*
- e) *Any other writ, order or direction which this Hon'ble Court may deem fit and proper also be issued in favour of the petitioners and against the respondents.*

Whereas, the above titled writ petition has come up for hearing before the Hon'ble Court on 10.04.2023 and on the said date, the Hon'ble Court while having regard to the large number of respondents in the writ petition, has been pleased to allow the submission of Id. Counsel for the petitioners for service of the notice upon the respondents 3 to 192 through publication.

Now, therefore, in compliance to the Hon'ble Court Order (Supra), the instant notice is hereby issued, calling upon the respondents 3 to 192 to appear either in person or through counsel or any authorized agent on the **next date of hearing i.e. 23.05.2023 at 10:30 AM** before the Hon'ble High Court of J&K and Ladakh, Srinagar and to file reply/objections, if any, in the matter.

*Herein fail not at your peril.*
