



- v) the interview shall start at 11:00 am on the scheduled dates, however, the candidates shall report at the venue of the interview at 10:00 am;
- vi) the candidates are required to produce sufficient proof of their identity in the form of Adhar Card or Pan Card or DL



- or Passport or any document of like nature at the time of interview;
- vii) the candidates shall have to produce all original certificates/testimonials before the interview committee at the time of their interview. Any candidate who fails to produce his/her original certificates/testimonials may forfeit his/her candidature;
- viii) only those shortlisted candidates shall be allowed to appear in the interview who fulfil all the notified eligibility requirements;
- ix) mere figuring of roll number of a candidate in the shortlist may not entitle a candidate to appear in the interview which shall be subject to the scrutiny of all testimonials of the shortlisted candidates;
- x) no individual call letters shall be issued to the candidates whose roll numbers figure in *Annexures- "A", "B" & "C"* to this Notification;
- xi) in the event of any deficiency found at the time of interview with reference to the eligibility of any candidate, such candidate may not be allowed to appear in the interview;
- xii) no TA/DA shall be paid to the candidate for appearing in the interview.






