Whereas, the Government vide Circular No. 35-JK(GAD) of 2022 dated 12.10.2022 has impressed upon employees of all the Departments across Union Territory of J&K to visit Jammu and Kashmir Human Resource Management System (JKHRMS) on <u>https://(hrms).jk.Gov.in</u> and register on the system by using CPIS Numbers and check / modify their basic as well as other service related details.

Whereas the factual position was brought to the notice of Hon'ble the Chief Justice (A) for soliciting orders and His Lordship upon perusal has been pleased to direct as under:

> "Since information pertaining to the Judicial Officers, Officers, staff of High Court & District Courts, sought through Govt Circular No. 35-JK (GAD) of 2022 Dated 12.10.2022 regarding implementation of J&K Human Resource Management System (JKHRMS) had been already uploaded on Centralized Personnel Information System (CPIS), therefore, there is no need separately to upload same information again on JKHRMS Portal".

Now, therefore, on the strength of aforesaid direction all Judicial Officers, Officers and staff of High Court of J&K and Ladakh and District Courts of UT of J&K are hereby informed that there is no need to register and upload their information on JKHRMS portal in response to, GAD Circular No. 35-JK(GAD) of 2022 dated 12.10.2022. They may, however upload information on Central Personal Information System (CPIS), if not uploaded earlier.
