The engagement of services of the above named officers /officials shall be subject to the following stipulations:

 The engagement shall be, in the first instance for period of three months subject to review after every one month and a report in this regard shall be furnished by the concerned Registrar Judicial to the undersigned.



- 2. The concerned Registrar Judicial shall evaluate and evolve effective supervisory mechanism to monitor the work and performance of the retired working employees to ensure optimum utilization of their working capacity.
- 3. The engaged retired employees shall be paid fixed remuneration in the following manner:
 - i. Retired Gazetted Employees: Rs. 30,000/ per month.
 - ii. Non Gazetted officials other than Class-IV Employees: Rs. 25,000/ per month.
 - iii. Class-IV Employees: Rs. 15,000/ per month.
 - 4. The above said remunerations are lump sum in nature and no other amount shall be payable and allowances/facilities such as transport etc. shall not be admissible.
