- 8) Ms Khatoon Didi, Section Officer (Adm.), Principal District & Sessions Court, Leh upon her promotion as Chief Administrative Officer is transferred and posted as such in the Court of Principal District & Sessions Judge, Kargil against the available vacancy.
 - Shri Nazir Ahmad Bhat, Section Officer (Reader), Principal District & Sessions Court, Srinagar who is due for promotion w.e.f 01.10.2020 against the anticipated vacancy upon his promotion as Chief Administrative Officer is transferred and posted as such in the Court of Principal District & Sessions Judge, Shopian against the available vacancy. He shall join his new place of posting after 30.09.2020 i.e. when the post of Chief Administrative Officer against which he is posted becomes available due to superannuation of Shri Muneer Ahmad Qadri on 30.09.2020.
- 12) Smt Madhu Sharma, Chief Administrative Officer posted in the Court of Principal District & Sessions Judge, Samba is transferred and posted as such in the Court of PDJ, Jammu against the available vacancy.
- 13) Shri Naseer Ahmad Wafai, Chief Administrative Officer posted in the Court of PDJ, Ganderbal is transferred and posted as such in the Court of PDJ, Srinagar against the available vacancy.
- 14) Shri Sudershan Kumar, Chief Administrative Officer posted in the Court of PDJ, Ramban is transferred and posted as such in the Court of Principal District & Sessions Judge, Udhampur against the available vacancy.

All the Presiding Officers shall ensure that transferees are relieved within 10 days from the date of issuance of this Order. Concerned Principal District & Sessions Judges shall personally monitor the implementation of this order and report compliance.
