

1. All the concerned Pr. District & Sessions Judges shall make further postings/adjustments of all the transferees within their respective Districts within a period of four days as per the availability of vacancies, under intimation to this Secretariat.
2. The transferees who have been retained in any judicial district shall be shifted from their current station if no indication to the contrary has been mentioned in column 5.
3. In case of shifting of any transferee from one station to another in a district, if vacancy is not available, Pr. District & Sessions Judge concerned may transfer a person with longest stay to another station in the district to create a vacancy.
4. All the Presiding Officers shall ensure that transferees are relieved within 10 days from the date of issuance of this order and the concerned Pr. District & Sessions Judges shall personally monitor the implementation of the order and report compliance.


