Consequent upon the finalization of the selection process and preparation of select lists by the Selection Committee, constituted for recruitment to the posts of the Junior Assistants in Subordinate Courts of the State advertised vide High Court Notification No. 323 dated 26.05.2017, and the approval of the recommendations of the Selection Committee by Hon'ble the Chief Justice (Appointing Authority), the following candidates (category wise and in order of merit) are temporarily appointed as Junior Assistants in the Pay Scale of Rs. 5200-20200 with Grade Pay of Rs. 1900 in Subordinate Courts of Kashmir and Jammu divisions of the State:
