Under the Consumer Protection Act, 1986, the Government of India has established the National Consumer Disputes Redressal Commission (NCDRC), which is located in New Delhi. The powers and functions of the NCDRC are as per the Consumer Protection Act, 1986.
2. It is proposed to appoint Members in the National Consumer Disputes Redressal Commission.
3. The eligibility criteria are as follows:

A person shall not be qualified for appointment as Member unless he is a person of ability, integrity and standing and having special knowledge of and professional experience of not less than twenty years in economics, business, commerce, law, finance, accountancy, management, industry, public affairs, administration or any other matter which in the opinion of the Central Government, is useful to the National Consumer Disputes Redressal Commission.


Provided that a person shall not be appointed as a Judicial Member, unless he-
(a) is, or has been, or is qualified to be, a Judge of a High Court ;
(b) has, for at least 10 years, held a Judicial office in the territory of India.
4. The Consumer Protection Act, 1986 was amended in March, 2017 by the Finance Act, 2017 and section 22E was inserted, wherein, inter alia, the maximum age for Member shall not exceed 67 years. This amendment is before the Hon'ble Supreme Court in W.P.(C ) No. 279/2017 (Kudrat Sandhu vs Vol) and other connected cases including W.P. (C) No. $1129 / 2017$ (Gokul Pattnaik Vs Vol) and W.P. (C) No.33/2018 (Jyoti Ojha Vs Vol) and judgement of the Hon'ble Supreme Court is awaited.
5. Every Member shall hold office for a period of five years from the date on which he/she enters upon his/her office. The term of appointment is, however, subject to the maximum age limit of 67 years. The stipulation of maximum age will be subject to the final outcome in the cases as at para 4 above.
6. The salary of a Member shall be Rs 2, 25,000/- per month. The allowances and other terms and conditions of service of the Members shall be as laid down in the Tribunal, Appellate Tribunal and other Authorities (Qualifications, Experience and other Conditions of Service of Members) Rules, 2017 and shall be subject to the final outcome of the W.P.(C ) No. 279/2017 (Kudrat Sandhu vs Union of India) and other connected cases pending before the Hon'ble Supreme Court.
7.
