4. The maximum age limit for the re-employment on contract basis is 64 years. The pay of the officer on re-employment on contract basis will be fixed as per DoP&T OM No. 3/3/2016-Estt (Pay-II) dated 1.5.2017.

The departmental officers in the feeder grade who are in direct line of promotion shall not be 5. eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointments by promotion channel.

The period of deputation including the period of deputation in another ex-cadre post held 6. immediately preceding this appointment in the same or other Government Organization or department shall not ordinarily exceed three years.
