- 2. The pay of the officer selected on deputation basis will be governed by DoP&T O.M. No. 6/8/2009-Estt(Pay-II) dated 17.06.2010, as amended from time to time.
- 3. The maximum age limit for appointment on deputation shall be 56 years as on the closing date for receipt of applications.
- 4. The maximum age limit for the re-employment on contract basis is 64 years. The pay of the officer on re-employment on contract basis will be fixed as per DoP&T OM No. 3/3/2016-Estt (Pay-II) dated 1.5.2017.

- 5. The departmental officers in the feeder grade who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointments by promotion channel.
- 6. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other Government Organization or department shall not ordinarily exceed three years.
- 7.
