- 4. The maximum age limit for appointment by deputation shall not exceed 56 years with a residual service of four years as on the closing date of receipt of applications.
- 5. The application in the prescribed pro forma (Annexure-I) of the eligible officer, who can be spared in the event of his/her selection may be forwarded to the Principal Registrar (I/C), Armed Forces Tribunal, Principal Bench, West Block-VIII, Sector-I, R.K.
