- c) has held office as the Presiding Officer of a Debts Recovery Tribunal for three years.

3. The Chairperson of a DRAT shall hold office for a term of four years or till he attains the age of seventy years, whichever is earlier. Provided that a person who has not completed the age of fifty years shall not be eligible for appointment as a Chairperson.

4. In accordance with the Rule 11(1) of the above cited Rules of 2020, the Chairperson of the DRAT shall be paid a salary of Rs.2,50,000 (fixed) and other allowances and benefits as are admissible to a Central Government officer holding posts carrying the same pay. The terms and conditions of service applicable to the post of Chairperson of a DRAT shall be regulated in accordance with The Tribunal, Appellate Tribunal and other Authorities (Qualifications, Experience and other Conditions of Service of Members) Rules, 2020 and amendments, if any, as applicable on the date of appointment of the Chairperson.
