Note 8:	If the listed matters related to personal liberties are not taken up for any reason in first half of the day in that event these matters shall be taken up by the concerned Benches at the beginning of the post lunch session as per the convenience of the concerned roster bench.		
Note 9:	First ten cases in the list before the Bench(s) shall not be ordinarily adjourned.
