3. Various items/scraps put to auction (as per list enclosed under Annexures in this bid) shall be considered by the bidder as 'ONE LOT' only and the Reserve Value for the whole lot is **1,33,000/- (Rupees One Lac Thirty Three Thousand Five Hudred Only)**.
