

Interested parties having indepth knowledge and experience in the field of data entry may submit their bids in sealed envelopes upto 18-05-2017 4 PM in the office of the undersigned. Bids will be opened in presence of the bidders/representatives on 19-05-2017 at 12 noon.

TERMS AND CONDITIONS

- (1) Time for completion of work allotted is 21 days from the date of issuance of work order.
- (2) All the logistic support like computer systems, power backup etc will be provided by the High Court subject to the availability.
- (3) Bids must be accompanied with CDR of Rs 2000/= (Rupees two thousand only) in the name of Registrar General High Court of Jammu and Kashmir Srinagar.
- (4) CDR of successful bidder will be returned back within seven days of completion of work and that of unsuccessful bidders within three days of award of contract.
- (5) Rates must be quoted per form. For calculation purposes Forms A&B will be treated as two forms.
- (6) Besides filling in the details, bidders have also to scan and paste photograph of the Advocate on the form A or B whichever is applicable.
