All the vendors should submit the Tender/Sealed-quotations on or before 24.07.2017 up to 04.00 pm which will be opened on the same day at 4.30 PM. The Bid /Sealed Quotation/ Tender should reach physically or by post/courier on or before the last date & time fixed for submission of quotations in the office Central Project Coordinator High Court of Jammu & Kashmir at Srinagar. Bids received after due date and time shall not be considered.

2.Bid Submission:

The bidders fulfilling the Terms and Conditions as prescribed below, may submit their bids to the Central Computer Coordinator, High Court of Jammu & Kashmir, Srinagar. The Technical and Commercial bids should be in two separate sealed covers marked 'Technical bid' and Financial bid'. Both the covers shall then be submitted in one single cover superscribed as "Quotation for <u>Comprehensive Annual Maintenance Contract of LAN Components & Hardware items</u>". Technical Bid' will be opened first and only those firms, which fulfill the 'Technical Terms and Conditions', will be eligible for participating in the 'Financial Bid'.

HIGH COURT OF JAMMU AND KASHMIR AT SRINAGAR

General Terms and Conditions

- 1. The Bidders are expected to examine all instructions, forms, terms and conditions in the bidding Documents. Failure to furnish all the information required by the bidding Documents or submission of a Bid not substantially responsive to the bidding Documents in every respect, shall be at the Bidder's risk and may result in rejection of the Bid. The Bid is liable to be rejected out rightly without any intimation to the Bidder, if complete information called for the Tender Document is not given therein or if any particular asked for in the Forms / Proforma in the Tender are not fully furnished.
- 2. The vender should have its Office/Service Centre in each capital city of J&K State. The same may be inspected by the Technical Team of High Court.
- 3. The vender should have done similar type of work and must have completed at least two such tenders during the last five years.
- 4. The prices quoted by the Vendor shall be in Indian rupees, and not be subject to any price escalation. Levies, Taxes if any introduced by The Government will be extra.
- 5. The Annual Maintenance Contract is valid for one year from the date of award of contract, after receipt of approval.
- 6. High Court of Jammu and Kashmir reserves the right to split orders and / or accept or reject any quotation as also to alter any or all of the terms and conditions without assigning any reasons thereof.
- 7. The Annual Maintenance Contract shall cover "Comprehensive maintenance including preventive maintenance/regular services of the LAN Nodes (LAN Networking), Rack Mount Servers, Routers and LAN switches and all accessories/or replacement of all such hardware/items necessary for keeping the items under AMC in prefect working order and condition at all the times during the period of the AMC from any defects/disturbance or any unscheduled call for corrective and maintenance services, by taking appropriate steps on time to set right the full functioning of the LAN Nodes, Rack Mount Severs, Routers & Switches.
- 8. The comprehensive maintenance shall be carried out at all the District Court Complexes & subordinate Courts of Jammu & Kashmir or wherever the

LAN Nodes ,Rack Mount Severs , Routers &Switches have been installed. In case the vendor feels that the equipment cannot be repaired on site, then they will carry and deliver the equipments at their own cost and risk to get it repaired promptly and provide standby forthwith in lieu thereof and Job card will be maintained strictly and signature of the users will be obtained on every visit. List of Courts/Court Complexes is provided under **Annexure-B**.

- 9. In case of specified Computer Hardware items being shifted to any other locations, maintenance shall continue to be applicable.
- 10.In case, for any reasons the specified Hardware under maintenance are discontinued for use by the High Court of Jammu and Kashmir, the said Hardware items will be removed from AMC.
- 11.In case of any up-gradation in the system during the proposed maintenance period, the maintenance shall be continued to cover the upgraded system during Contract period.
- 12. The Vendor shall not have any objection regarding the third-party Hardware installation by High Court of Jammu and Kashmir, during the Contract period.
- 13. The Vendor shall arrange quarterly visit of the Specialist Engineer to assess the Serviceability state of the hardware.
- 14. The vendor shall attend all the complaints irrespective of their nature and shall attend the complaints without fail within shortest possible time and in no case shall exceed 2 days down time. Vendor will be required to attend complaints during odd hours and on Court's holidays. The vendor shall provide e-mail ids and contact numbers for logging of complaints and shall also provide escalation matrix for resolution of the complaints.
- 15. The firm must be registered as limited or private limited/any govt organization under the Companies Act.
- **16.**List of Hardware Items for Annual Maintenance Contract is enclosed as **Annexure "B"**

Opening of Bids and Bid evaluation :-

1. Technical Covers will be opened as per Schedule mentioned in the Tender Document and the Financial Covers of technically qualified Bids will be opened on the later date.

2. The decision of the Evaluation Committee in the evaluation of the Qualification criteria and Commercial Bids shall be final. No correspondence will be entertained outside the process of negotiation / discussion with the Committee.

Note: High Court of Jammu and Kashmir may waive any minor informality or non-conformity or irregularity in a Bid.

3. High Court of Jammu and Kashmir reserves the right to accept or reject any Bid and to annul the Bidding process and reject all Bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for Tendering Authority's action.

Bid Security (EMD - Earnest Money Deposit)

- 1. The interested parties are required to submit refundable EMD of Rs. 10,000/- (Rupees Ten Thousand Only) by Demand Draft.
- 2. Bidder registered with MSMED, NSIC will have to submit copies of Registration certificate to claim exemption from tender fee and EMD.
- 3. The Earnest Money Deposit will be returned to the unsuccessful bidder within seven days of opening of financial bids and to the successful bidder within fifteen days of award of contract.

Performance Bank Guarantee:-

- 1. The successful Bidder shall at his own expense submit within fifteen (15) working days from the date of Notice of award of the Contract or Prior to signing of the contract whichever is earlier, an unconditional and irrevocable Performance Bank Guarantee of an amount equivalent to 5% of Contract value in Indian Rupees. Proforma for Bank Guarantee is given under **Annexure-C**.
- 2. No interest shall be payable on the Performance Bank Guarantee.
- 3. Performance Bank Guarantee shall remain valid for the period of Contract.

Contract / Agreement:-

1. The successful Bidder shall enter into an agreement with the Tender Issuing Authority, as per Terms and Conditions so as decided by The High Court of Jammu and Kashmir.

2. Failure of the successful Bidder to agree with the Terms and Conditions of the Bid/Contract shall constitute sufficient grounds for the annulment of the award, in that event, Tender issuing Authority may make the award to the next Best Value Bidder or call for new Bids.

Scope of Work & Uptime guarantee: -

- 1. The Vendor shall guarantee a minimum up time of 98% during the maintenance period. The Vendor shall always maintain a detailed 'breakdown and repair' records of the items under AMC Contract.
- 2. In case of break down or occurrence of any obstacle in functioning of the specified Computer Hardware items, the Vendor shall ensure that the same is repaired within specified time. In case of failure to repair the same within stipulated time the Vendor should provide equivalent or higher configuration spare replacement, without any additional charges.
- 3. The spare parts for standby or replacement shall be 100% compatible and shall support respective equipment in the specified Computer Hardware items and spare parts are to be made available at site.
- 4. The Vendor shall appoint one well experienced Service Engineer exclusively for attending complaints and its resolution under the Contract. He will receive complaints and keep a proper Call Log Record. Call Logging to the company and follow up for receiving and replacing component will be responsibility of Service Engineer.
- 5. If the Vendor(s), so desire, they may obtain detailed information about the locations and configuration of the items mentioned in Annexure "B" on any working day between 10:00 am to 5:00 p.m. from the office of the Central Project Coordinator, High Court of J&K.

Confidentiality: -

- 1. The Vendor shall not divulge to any person, subsidiaries or groups of the Vendor or to any other person, any information obtained by it in the course of its execution of its work and all the information gathered by the Vendor shall be treated as professional communications and confidential. Any violation of this clause shall lead to cancellation of the Contract and invoking of the Bank Guarantee, if any, without notice to the Vendor and he shall be liable for further damages.
- 2. The Vendor shall not encourage or partake in any form of Software piracy during the Contract period.

3. The Vendor shall not take High Court Jammu & Kashmir as reference to their prospectus of clientele for any purpose.

Termination: -

- 1. High Court of Jammu and Kashmir reserves the right to terminate the Contract by giving due notice in case of breach of any of the material obligations under the Contract, if committed by the Vendor, during the Contract period.
- 2. The Contract may also be terminated in case of any unsatisfactory service performance during the Contract period with due notice.

Payment Terms: -

- 1. Payment will be made on quarterly basis i.e. at the end of every quarter after satisfactory report received from Pr. District & Sessions of all the Districts on prescribed format.
- 2. The payment would be made after deducting necessary taxes, penalties etc. if applicable.

Downtime Penalty:-

The response time, removal of defects etc. must be as under, failing which, penalty mentioned against hardware items shall be levied against the vendor as below:

For other Component: 24 hours failing which without proper, genuine satisfactory penalty @ Rs.100/- per day.

In case of inordinate delay in rectifying the defect is noticed, High Court shall have every right to repair defective Hardware at Vendor's cost.

Arbitration:-

In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and / or in relation to the implementation or interpretation thereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the sole arbitrator appointed by Registrar General, High Court of Jammu and Kashmir.

<u>Legal Jurisdiction</u>:- All Legal disputes are subject to the jurisdiction of Jammu and Kashmir only, preceded by Arbitration.
