## SHORT TERM TENDER NOTICE

High Court is inviting short term tenders for supply and installation of 124 No. of 600 VA UPS, 29 No. of 3 KVA Servo Stabilizers and 2 No. of 6 KVA Servo Stabilizers for use in the Subordinate Courts details of which are annexed in **Annexure-I**. Complete specifications of the tendered items are given in **Annexure-II**. Technical and commercial bids may be submitted in two separate envelopes superscribed as "Technical" and "Commercial" up to 19-08-2017 4 PM in the office of the undersigned. Bids will be opened in presence of the bidders/representatives on 21-08-2017 at 11 AM.

### GENERAL TERMS AND CONDITIONS

- (1) Time for completion of supply and installation is 15 days from the date of issuance of Purchase order.
- (2) Bids must be accompanied with EMD of Rs 30,000/= (Rupees thirty thousand only) and non-refundable tender fee of Rs 500/- (Rupees five hundred only) in the name of Registrar General High Court of Jammu and Kashmir Srinagar.
- (3) Rates must be quoted per item. Rates must be inclusive of taxes and installation charges. Proforma of price bid is given under **Annexure-III**.
- (4) Bidders must clearly mention the period of warranty of the items offered.
- (5) Validity of rates quoted should not be less than six months.
- (6) Successful bidder has to provide onsite service support for the period of warranty.
- (7) During warranty period, the vendor has to attend the complaints without fail within the shortest possible time and in no case shall exceed two days downtime.
- (8) The vendor should have done similar type of work and must have completed at least two such tenders during the last five years.
- (9) The vendor must have a cumulative turnover of at least Rs 20 lakh during the last three financial years i.e, 2013-14, 2014-15, 2015-16 from the computer related business.
- (10) The prices quoted by the Vendor shall be in Indian rupees, inclusive of all taxes and not be subject to any price escalation.

- (11) Bidders can quote all or any of the tendered items. High Court of Jammu and Kashmir reserves the right to split orders and / or accept or reject any quotation as also to alter any or all of the terms and conditions without assigning any reasons thereof.

**Eligibility Criteria:**

Bidder must have:

1. Registration Certificate for Sole Proprietorship Firms.
2. Registered number of GST where his business is located and Income Tax/Pan/TIN and must submit copies of relevant certificates with the technical bid.
3. Letter of authorisation from the OEM. If the OEM is the bidder itself, then letter of incorporation of OEM.
4. A Bidder who is blacklisted from any other Govt. institution is not eligible to participate in this tender. Similarly, at the time of bidding, the firms blacklisted/debarred in participating in any activities for fraudulent or corrupt practices by any State or Central Govt. or UT in India are not allowed to bid. For not being so debarred, the bidder must enclose a self-certified letter as proof.

**Opening of Bids and Bid evaluation :-**

1 Technical and financial bids will be opened at the same time as per Schedule mentioned in the Tender Document. However, evaluation of technical bids will be carried out later on and results of the evaluation will be notified to the bidders through the official website of the High Court <http://jkhighcourt.nic.in>

2. The decision of the Evaluation Committee in the evaluation of the Qualification criteria and Commercial Bids shall be final. No correspondence will be entertained outside the process of negotiation / discussion with the Committee.

**Note:** High Court of Jammu and Kashmir may waive any minor informality or non-conformity or irregularity in a Bid.

3. High Court of Jammu and Kashmir reserves the right to accept or reject any

Bid and to annul the Bidding process and reject all Bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for Tendering Authority's action.

**Payment Terms: -**

1. Payment will be made on successful installation and testing of UPS and Stabilizers at the desired locations. Certificate of successful installation shall be provided by concerned Judicial Officer of the Court.
2. The payment would be made after deducting necessary taxes, penalties etc. if applicable.

**Bid Security (EMD – Earnest Money Deposit)**

1. EMD Rs. 30,000/- (Rupees Thirty thousand only). Payment can be made through FD/DD/CDR/Bank Guarantee valid for three months in each case favouring Registrar General High Court of Jammu and Kashmir payable at Srinagar.
2. A non-refundable tender fee of Rs 500/- (Rupees five hundred only) in the form of DD favouring Registrar General, High Court of J&K and payable at Srinagar must also accompany the bid.
3. Successful bidder will have to submit Performance Security Deposit of 5% of actual value of contract through bank guarantee in favour of Registrar General, High Court of J&K valid for the period of contract including the period of warranty.
4. The Earnest Money Deposit will be returned to the unsuccessful bidder within seven days of opening of financial bids and to the successful bidder within fifteen days of award of contract.

**Performance Bank Guarantee:-**

- 1 The successful Bidder shall at his own expense submit within fifteen (15) working days from the date of Notice of award of the Contract or Prior to signing of the contract whichever is earlier, an unconditional and irrevocable Performance Bank Guarantee (**Annexure-IV**) of an amount equivalent to 5% of Contract value in Indian Rupees.
- 2 No interest shall be payable on the Performance Bank Guarantee.

3 Performance Bank Guarantee shall remain valid for the period of Contract.

**Contract / Agreement:-**

1 After letter of acceptance is issued but before award of contract, the successful Bidder shall submit an undertaking within the stipulated time that the terms and conditions are acceptable to him.

2 Failure of the successful Bidder to agree with the Terms and Conditions of the Bid/Contract shall constitute sufficient grounds for the annulment of the award, in that event, Tender issuing Authority may make the award to the next Best Value Bidder or call for new Bids.

**Legal Jurisdiction:-** All Legal disputes are subject to the jurisdiction of Jammu and Kashmir only, preceded by Arbitration.

We (indicate name of the bank) further agree with the JKHC that the JKHC shall have the fullest liberty without our consent and without affecting in any manner our obligations hereunder to vary any of the terms and conditions of the said agreement or to extend time of performance by the said Contractor(s) from time to time or to postpone for any time or from time to time any of the powers exercised by the JKHC

against the said contractor(s) and to forebear or enforce any of the RFP conditions for selection of the vendor for supply of Desktops and we shall not be relieved from out liability by reason of any such variation or extension being granted to the said Contractor(s) or for any forbearance, act or omission on the part the JKHC or any indulgence by the JKHC to the said contractor(s) or by any such matter or thing whatsoever which would but for this provision, have effect of so relieving us.

6. The liability of us .....(indicate the name of Bank) under this guarantee will not be discharged due to the change in the constitution of the Bank or the Contractor(s)
